

# ADA COUNTY SHERIFF LABOR DETAIL (SLD)

## Participation Contract

1. Headcount begins promptly at 7:30 a.m. on your scheduled workdays. Headcount will be conducted in front of the Work Release Center @ 7255 Barrister Dr. Parking is provided across the street in the dirt lot.
2. There must be no trace of alcohol or drugs in your system. By signing this contract you consent to alcohol/drug testing.
3. You must wear appropriate clothing for the weather. This includes a hat, gloves, coat, sunscreen, etc. *You must wear long pants, shirts and closed-toed shoes. No sandals, shorts, or sleeveless shirts are allowed.*
4. You will be required to wear safety vests throughout the workday. These will be provided to you.
5. Do not bring pocketknives, leathermans, fingernail clippers, or any other sharp items that may be used as a weapon. ***Do not bring cellphones or electronic devices of any kind!!!***
6. Smoke breaks will be given during the day. At no other time is smoking permitted. No smoking around the Work Release Center except at the designated area.
7. No personal visits or telephone calls. In an emergency, family may call the Work Release Center at 577-3461 or the Day Reporting Center at 577-3460.
8. You are responsible to control your behavior, including actively avoiding all swearing, anger out bursts, and negative comments.
9. You must obey all orders from the deputies; this includes performing all work assignments and safety requirements. **If your work effort does not meet the standards of the work crew supervisor, or you act in an unsafe manner, you will not be given credit for the day, will be charged \$50, and will have to reschedule the day.**
10. Lunch and water will be provided. *Do NOT bring other foods or drinks, Except Water!*
11. You shall not approach or stand near any of the fenced areas in front of the Day reporting Center. Stay within the designated areas. Any bikes secured to the Chain link fences will be confiscated !
12. Do not tamper with any tool, equipment or another person's property.
13. Being unsafe around the highways is forbidden. Do not walk out into traffic. Wait for a Supervisor to tell you when to cross.
14. Do not trespass onto private property. If you are unsure of the boundaries ask the deputy.
15. If you are injured you must notify the Deputy immediately. An incident report must be completed no matter how minor the injury.

I have read, understand, and agree to the above terms. **I understand that I will be charged \$25.00 for every approved rescheduled day and \$50.00 for a NO SHOW day. Rescheduling is at the discretion of SLD staff only. Reschedules must be done in person prior to that SLD day. There will be no reschedules of previous rescheduled days. If I have a medical emergency on a scheduled day, I understand I must notify SLD staff that day BY 7:30 am at 577-3460 or an affidavit will be issued for my arrest.** I understand that if I violate any of these rules that I may be terminated from the program or subject to a \$50.00 reschedule fee for a 1<sup>st</sup> offense rule violation if that SLD day cannot be done. In the event that I am removed from the program, all SLD fees paid are forfeited and will not be refunded and I will serve the remainder of my sentence incarcerated. By signing this contract, I also agree to abide by all the laws of the United States, State of Idaho, and Ada County.
